The following terms and conditions shall apply. VIOLATION of any of these terms SHALL CANCEL THIS CONTRACT.

1. This contract does not allow subletting of space nor is it transferable. APPLICATIONS MUST EXHIBIT ALL 5 DAYS OF THE FAIR.
2. The exhibitor accepts full responsibility for all liabilities for damages to person or property arising out of his/her use and occupancy of these premises.
3. The Kenosha County Fair will NOT be responsible for any loss by theft, fire, accident or act of God.
4. The cost of electrical connection, inspection fees and special phone fees are to be borne by the exhibitor. Exhibitors will provide their own tables, chairs, extension cords, etc. Electrical cords must be continuous with a 3 wire grounded plug.
5. The applicant shall not interfere with other exhibitors by activity beyond the spaces rented or be nuisances such as excessive volume on a public address system, musical instruments, etc.
6. Posting of flyers will not be allowed to any Fair Grounds property, either permanent or temporary, or to a vehicle upon the Fair Grounds.
7. The Kenosha County Fair reserves the right to cancel or deny any application by refunding the deposit and indicating the reason for the cancellation or denial. **No refunds or deposits** except by cancellation or denial of the contract. Checks returned NSF will automatically cancel contract.
8. The Fair reserves the right to assign booth location and will take in account the preference if any, of the Exhibitor.
9. Only vehicles ABSOLUTELY needed to hold inventory will be allowed to remain in the display area during normal exhibit hours. This display area is a different area for exhibitors. These vehicles will be assessed a rental fee on the same basis as the regular exhibitor rental fee. Vehicles used for overnight accommodations will be assigned a camping location and a camping fee.
10. A designated area will be provided for all stock/storage units. A fee will be charged \$30.00 for Parking only. \$95.00 if electric is required. Space assignments will be determined by Director of Privileges. If storage unit is part of the exhibit, it must be noted with contract before spaces assigned.
11. Exhibitors at the Kenosha County Fair shall not sell, or allow to be sold any sharp instruments which includes not limited to throwing stars, knives, chains, darts, etc. or any firearms of any description, dangerous weapons or explosives without the prior approval of the Fair.
12. Commercial Exhibit Buildings and outside exhibit area hours are 10:00 AM to 10:00 PM each day except Sunday. Sunday hours are 10:00 AM to 9:00 PM. In fairness to exhibitors and the public, all exhibits should be staffed during the hours previously stated. Outside exhibits may remain open until the Midway Closes. Food concessions may remain open until it is not profitable. **If you are applying for a food concession you will need to meet the State Department of Health or Agriculture standards.**
13. All exhibits may be set up Monday and Tuesday between 9:00 AM and 6:00 PM, or from 8:00 AM to 10:00 AM on Wednesday. All exhibits should be ready to open by 10:00 AM Wednesday.
14. **ONE FREE** pass is provided with each contract. Please purchase tickets for concessionaires at time of application.
15. Exhibitor shall provide sufficient containers for trash in exhibit space. Concessions that produce excess refuse and garbage as part of their operation will be subject to haulers fee.
16. Exhibitor agrees to: **Not to remove or dismantle exhibit until the official closing time of the Fair, 9:00 PM on the last day of the Fair and remove same not later then 4:00 PM on the day after the fair closes. EARLY DEPARTURE WILL AUTOMATICALLY FORFEIT ANY FUTURE RENEWAL OF THE CONTRACT.**
