

**Antique Tractor and Machinery Display**  
**Kenosha County Fair**  
**2022**

The Kenosha County Fair encourages the display and demonstration of tractors, implements and machinery made prior to 1960. To fulfill the mission of providing agricultural education, the display of this equipment gives fair guests a glimpse of a by-gone era.

The guidelines for displaying equipment are as follows:

1. Tractors considered for display must be in running condition or “parade ready”.
2. Equipment of all ages will be accepted.
3. Equipment must be in place by Tuesday night of Fair Week unless other arrangements are made with Superintendent.
4. Owners of equipment such as threshers, shellers, grinders, and sawmills are encouraged to demonstrate their equipment for the public during the fair.
5. There will be an antique tractor parade in front of the grandstand on Thursday night of the Fair at 5PM. It is open to all owners of tractors on display.
6. Each exhibitor of tractors and large equipment will be granted one five-day pass for each piece of equipment on display up to a maximum of 2 (two) five-day passes and 1 “B” parking permit. The purpose of the passes is to allow the exhibitors to provide supervision for the display area, demonstrate their equipment and be a resource for the fair visitors. In addition, each tractor owner is encouraged to participate in the tractor parade.
7. Persons desiring to exhibit their tractor(s) at the fair should complete an entry form and return it to the Kenosha County Fair office at the address on the form or return to Superintendent at the time of entry.
